


MCCC RUNOFF ELECTIONS RESULTS SPRING 2022

I. Secretary Runoff Response Rates

When there is a contested election for Part-Time/DCE At-Large Director, only those members who are Part-Time/DCE members without a Full-Time/Day position may vote for that position. However, since all members may vote for the Secretary position, only the total numbers are reported below.

The original election for Secretary resulted in a tie. While the MCCC ByLaws are silent on tie votes, they do incorporate Robert's Rule of Order, Newly Revised, which requires repeated elections for any tied positions until a majority for one candidate is obtained (RR NR 12th Ed., §46.32).

III. Original Response Rates

When there is a contested election for Part-Time/DCE At-Large Director, only those members who are Part-Time/DCE members without a Full-Time/Day position may vote for that position.

However, since this year the position was deemed elected, there was no distinction between Part-Time/DCE ballots, and Full-Time/Day ballots, so only the total numbers are reported below.
